NEW! July 16, 2024 - New Data Show Antimicrobial-resistant Pathogens Remain Elevated Post-pandemic

CDC used new data to analyze the U.S. burden of seven antimicrobial-resistant pathogens typically found in healthcare settings from 2021 through 2022. A [new fact sheet](#) shows that six bacterial antimicrobial-resistant hospital-onset infections increased by a combined 20% during the COVID-19 pandemic compared to the pre-pandemic period, peaking in 2021, and remaining above pre-pandemic levels in 2022.

In 2022, rates for all but one of these pathogens ([methicillin-resistant *Staphylococcus aureus*](#) or MRSA) remain above pre-pandemic levels. In addition, the number of reported clinical cases of [Candida auris \(*C. auris*\)](#)—a type of yeast that can spread in healthcare facilities, is often resistant to antifungal medications, and causes severe illness—increased nearly five-fold from 2019 to 2022.

ACIP Approves Vaccine Recommendations for Upcoming Respiratory Season — CDC's [Advisory Committee on Immunization Practices \(ACIP\)](#) voted to approve several [vaccine recommendations](#) for the 2024-2025 respiratory season during its June 26-28 meeting. CDC Director Mandy K. Cohen, MD, MPH, adopted the recommendations, making them official.

Regarding the [respiratory syncytial virus \(RSV\) vaccine](#) for older adults, CDC recommends everyone aged 75 years and older and adults aged 60-74 years who are at increased risk of severe RSV disease receive a one-time single dose of RSV vaccine.

For COVID-19, CDC recommends everyone aged 6 months and older receive the upcoming 2024-2025 formula [COVID-19 vaccine](#). The [interim clinical considerations for COVID-19 vaccines](#) will be updated soon.

Last, regarding the [influenza vaccine](#), CDC continues to recommend people aged 6 months and older who do not have contraindications receive an annual influenza vaccine. For solid organ transplant recipients aged 18-64 years who are on immunosuppressive medication regimens, CDC recommends high-dose inactivated (HD-IIV3) or adjuvanted inactivated (aIIV3) influenza vaccines.

The ACIP develops recommendations for U.S. immunizations, including ages when vaccines should be given, number of doses, time between doses, and precautions and contraindications. Summer Safety — Many of the 100 million Americans packing up for summer vacations this year will travel with grandparents or to grandparents' homes. With nearly three-quarters of older adults taking at least one medication daily, young children are at risk for unintentional medicine ingestion if medicines are left within their reach. Practicing safe medicine storage habits helps protect young children from a trip to the emergency room.

Share these medicine safety tips for traveling with kids and grandkids:

1. Keep all medicines out of sight and reach of children. Whether you are traveling with young children or hosting them, keep all medicines up and away and out of their sight and reach. Find

a safe place to keep medicines like a high cabinet or high closet shelf, and if you're in a hotel room, consider using the hotel room safe for safe storage.

2. Keep medicines in child-resistant containers. It may be tempting to transfer medicines to smaller containers for travel, but it's important to remember that containers such as pill organizers and baggies often lack the child safety features designed to prevent access by young children.
3. Ask the host where you can safely store medicines when you are a guest in their home, to ensure they're up and away, out of sight and reach of young children.
4. Save the Poison Help number (800-222-1222) in your cell phone so you'll have it in case of an emergency. Each poison control center is staffed with doctors, pharmacists, and toxicologists who can answer your questions 24/7. Make sure you have this number handy!

CDC's Morbidity and Mortality Report featured the article [Progress Toward Tuberculosis Elimination and Tuberculosis \(TB\) Program Performance — National Tuberculosis Indicators Project, 2016–2022](#).

This report is the first to describe a 5-year relative change for TB program performance. These results suggest that TB programs are making improvements in activities that help identify persons with TB and latent TB infection and ensure patients complete treatment in a timely manner.

NEW! July 16, 2024 **Get Inside, Stay inside, Stay Tuned**

Radioactive contamination and exposure could occur if radioactive materials are released into the environment due to an accident, event in nature, or intentional act. CDC works to protect people from radiation-related hazards, and provide best practices, guidance, training, tools, and information. While there is not an immediate threat of a radiation emergency, knowing the right steps to take can protect health.

Take Shelter

You cannot see, smell, feel, or taste radiation but you can still protect yourself from harm. If a warning is issued for a radiation emergency, take actions to stay safe.

Get inside:

- If you are outside when a radiation emergency occurs, get inside a building as soon as you can. The walls of a building or home can block much of the harmful radiation.
- If you can get to a brick or concrete multi-story building or basement within a few minutes, go there. If not, get inside any building that is available.

Stay inside:

- Once inside, go to the basement or the middle of the building. Stay as far away from the walls and roof as you can as radioactive material settles on the outside of buildings.
- Radioactive materials become weaker over time. Staying inside for at least 24 hours can protect you and your family until officials say it is safe to leave the area.

If you are in a car:

- Go to your home if it is close, or a nearby building. Otherwise, stop on the side of the road in the safest place possible and stay inside your car.
- Close the windows and turn off the air conditioner, heater, and vents. If you are able to do so, also cover your nose and mouth with a mask or cloth to avoid breathing radioactive dust or smoke.

Stay tuned:

- Radios, televisions, computers, and mobile and other communication devices are among the best ways to receive alerts, warnings, and updates with the latest information from public health or emergency officials.
- Stay inside until officials provide instructions or say it is safe to go outside.
- If you have evacuated the area, do not return until local authorities say it is safe to do so.

Protect Yourself After Exposure

If you think you have been exposed to harmful material during a radiation incident, follow these steps to remove radioactive particles from your body.

1. Take off outer layer of clothing:

- Carefully remove your outer layer of clothing to prevent breathing in loose radioactive dust. Put the clothes in a plastic bag or sealable container. Put the clothes bag in an out-of-the-way place, away from other people and pets.
- Avoid touching your eyes, nose, and mouth.

2. Get clean:

- Take a shower if you can. Use soap and shampoo.
- If you cannot take a shower, use a sink or faucet to wash your hands, face, and parts of your body that were uncovered.
- If you do not have access to a sink or faucet, use a moist wipe, clean wet cloth, or damp paper towel to wipe the parts of your body that were uncovered.
- While cleaning yourself, be careful to not burn, scrub, or scratch your skin.

3. Help others and pets:

- Help others, especially children and older adults, to get clean.
- When helping others, wear waterproof gloves and if appropriate for you, also wear the most protective [respirator, cloth, or surgical mask](#) you have. Talk to your doctor or health provider to determine if a mask is advised for you.
- Clean any pets that were exposed to radioactive material. Gently brush your pet's coat to remove radioactive particles and wash your pet with soap and water, if available.

After helping others or a pet, rewash your hands, face, and parts of your body that were uncovered.

Meet an Expert

What key advice do you have for community leaders to help their community be prepared for potential radiation exposure?

Official communications in the immediate area may be unavailable depending on the type of radiation incident. Infrastructure and communications systems might be damaged. Community leaders can help share messaging before, during, and after an incident using communication devices that are available. They can share recommendations for protective actions, evacuations, and locations of [community reception centers](#) and shelters in impacted areas.

What do you wish people knew about protecting themselves from radiation?

In most radiation emergencies, the best thing to do will be to get inside, stay inside, and stay tuned for more information from emergency officials. Three basic protective measures are “time, distance, shielding.” Minimize your time near the impacted area, put distance between yourself and the radioactive source, and shield yourself by getting inside a building or home.

What is the biggest challenge facing emergency response work after a radiation event?

Identifying the location of the contaminated area and what resources (fire, rescue, medical, public utilities) are available can be challenging. Finding such areas will make it possible for experts to recommend ways to reduce harmful health effects after determining if people, plants, animals, and the environment have been impacted.

NEW! July 11, 2024 - US CDC confirms 4th human case of H5N1 linked to dairy cattle outbreak; experts urge more widespread testing of humans, animals, wastewater

[Is H5N1 avian influenza here to stay?](#) Some experts are starting to wonder, worrying that a lackluster government response and little cooperation from US dairy farmers points to the virus becoming endemic in [poultry, cows, and other animals](#), with an ever-present risk of the virus [evolving to transmit more easily to and between humans](#). In the last 30 days, the US Department of Agriculture (USDA) has [reported detections of H5N1 avian influenza](#) (2.3.4.4b clade) in 49 dairy cattle herds in 6 states, bringing the total number of affected herds to 146 in 12 states since the outbreak was first reported in March.

On July 3, the [US CDC confirmed a fourth human case](#) of highly pathogenic avian flu in a dairy farm worker from Colorado, the latest linked to the current outbreak. The person experienced

[symptoms](#), including conjunctivitis (pink eye). The US has recorded a total of 5 human cases of H5N1 since 2022, with cases reported from 3 states (the first was in a person involved in culling poultry in Colorado). The CDC says the risk to the general public remains low at this time.

Colorado has had the [most affected dairy herds](#) in the past 30 days. After an outbreak was detected in a poultry flock of [1.7 million birds](#) at a large commercial egg producer in the state, Colorado Governor Jared Polis [declared a disaster emergency](#) to free up state resources to help officials and farmers respond.

Testing

[Bolstering testing strategies for H5N1 is critical](#) to identify and contain outbreaks early. Testing in both dairy herds and workers [remains largely voluntary](#), and [social stigma and economic concerns](#) hinder testing efforts. Federal agencies are looking for ways to [increase the number and types of tests](#) to effectively detect the disease in cattle and people. Some public health officials have suggested [anonymized testing](#) to get a broader picture of the outbreak, but doing so would limit the ability to address transmission at the source. Testing policies vary by state; [Michigan recently launched](#) a study to test people exposed to sick cows for H5N1 antibodies but participation rates are unclear. Most experts agree that [additional support for state and local public health departments](#) is necessary to boost surveillance, including for [wastewater testing programs](#), and that [current efforts are not sufficient](#).

Vaccines

The US Department of Health and Human Services (HHS) last week [awarded](#) US\$176 million to Moderna to develop an mRNA-based pandemic influenza vaccine. While one of the versions would target H5N1, the mRNA technology would allow manufacturers to [quickly adapt vaccines](#) if another flu strain emerged. The US government also secured a [fair pricing agreement](#), which it said will ensure equitable access. The government is [working with other pharmaceutical companies](#), including CSL Seqirus and Sanofi, to develop and stockpile other bird flu vaccines.

Meanwhile, [Finland is vaccinating workers](#) at poultry and fur farms and others at high risk against bird flu. Specifically, the nation is using a vaccine design based on the H5N8 avian influenza virus, which is expected to provide some protection against H5N1. Finland’s vaccination campaign is part of a broader European Union initiative, with [14 EU nations agreeing to purchase bird flu vaccines](#) through a plan established by the European Commission. Some experts are wondering [why the US government has not offered similar vaccination](#) for its farmworkers, veterinarians, and others at high risk of the disease.

Research & Raw Milk

A study published July 8 in [Nature](#) highlights the importance of monitoring and understanding the evolving nature of avian influenza viruses as they adapt to new host species. In the study, researchers demonstrated that [H5N1 isolated from infected cow milk](#) spread systemically in mice and ferrets, including to [mammary glands](#). Additionally, the virus was able to bind to sialic acids expressed in human upper airways and inefficiently transmitted to exposed ferrets (25% seroconverted with no virus detection). The virus’s ability to

[receptors](#) warrants further investigation, the researchers said, as past flu viruses that developed the ability to bind to both types have [led to human pandemics](#).

The study also found that mice can become sick after drinking even a small amount of infected raw milk, confirming previous research reported in the [New England Journal of Medicine](#). While there have not been any confirmed human cases of bird flu transmission related to raw milk consumption, public health [officials worry it is only a matter of time](#). Americans appear to have [little idea of the dangers](#) of raw milk consumption, according to a [recent poll](#) conducted by researchers at the University of Pennsylvania. Several US states, including [Delaware](#), are considering legislation to legalize the sale of raw milk for human consumption despite the risks. And it is not only bird flu that poses a risk. At least 165 people in California were recently sickened with salmonella infections in the [largest outbreak linked to raw milk](#) in the past decade.

Mpox outbreaks in South Africa, DRC raise concerns of broader spread, highlight need for equitable access to vaccines, treatments

South Africa is experiencing a concerning mpox outbreak, with [20 confirmed cases](#) reported between May 8 and July 2, including [3 deaths](#) (case fatality ratio [CFR] = 15%). All identified cases are male, mostly men who have sex with men, and many are living with HIV. The outbreak involves the clade IIb variant, the same one that drove the global epidemic in 2022, and shows signs of community transmission, as the [true number of cases is likely much higher](#). In response, South Africa has established a national Incident Management Team and implemented various public health measures.

Farther north, the [Democratic Republic of Congo \(DRC\) is facing its largest mpox outbreak ever recorded](#), declared an epidemic in December 2022, with more than 21,000 cases and more than 1,000 deaths since 2022. This outbreak is driven by the clade I virus, although the dominant strain being transmitted is a [new, potentially more dangerous strain](#), identified in the eastern part of the country. The new strain is [believed to be more easily transmissible](#), is causing more severe symptoms, and [significantly affecting children under age 5](#). The outbreak in DRC is primarily driven by sexual transmission but also shows evidence of spread through close skin-to-skin and/or household contact.

At least 25 cases have been [detected in the city of Goma](#), mostly in camps housing people fleeing nearby conflict. There are concerns the virus [may have already crossed borders](#) and could be silently spreading elsewhere, reminiscent of the 2022 epidemic. DRC recently granted regulatory approval for mpox vaccines, although no vaccines are available there yet, and few are available in South Africa. Experts say [both outbreaks highlight the need](#) for enhanced surveillance and equitable access to vaccines and treatments.

LEGISLATIVE ALERT | Summary of FY25 House Appropriations Bill | This week, the House Labor Health and Human Services and Education (LHHS) appropriations subcommittee released its version of the FY25 LHHS appropriation bill, detailing proposed funding levels across public health. Some related highlights include:

- The bill *eliminates* funding for **Firearm Injury and Mortality Prevention Research**, a decrease of \$12.5 million below the FY24 enacted level.
- The bill *eliminates* funding for the **Climate and Health program**, a decrease of \$10 million below the FY24 enacted level.
- The bill *eliminates* funding for the **Center for Forecasting and Analytics**, a decrease of \$55 million below the FY24 enacted level.
- The bill includes \$3.6 billion for **Administration for Strategic Preparedness and Response (ASPR)**, an increase of \$3 million above the FY24 enacted level.

The proposed funding levels in the bill may be altered as both chambers of Congress are anticipated to negotiate before the current fiscal year ends on September 30, 2024. [Learn more](#).
